

FACTS	WHAT DOES RANDALL, SEGREST, WEEKS, REEVES & SONES, PLLC DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies, including law firms who are title insurance agents, choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service that you have sought through us, including social security numbers, driver's license numbers, account numbers for your bank accounts, brokerage accounts, loan numbers, insurance policy numbers, mailing address(es), email address(es), and phone numbers.
How?	All financial companies, including law firms who are title insurance agents, need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons RANDALL, SEGREST, WEEKS, REEVES & SONES, PLLC chooses to share; and whether you can limit this sharing.

What we do

How often does RANDALL, SEGREST, WEEKS, REEVES & SONES, PLLC notify me about their practices?	We must notify you about our sharing practices when you request a transaction and we are doing so by this notice.
How does RANDALL, SEGREST, WEEKS, REEVES & SONES, PLLC protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We restrict access to nonpublic personal information about you to those employees who need to know that information to provide products or services to you.
How does RANDALL, SEGREST, WEEKS, REEVES & SONES, PLLC collect my personal information?	We collect your personal information in the real estate settlement related services, either directly from you or indirectly from a third party who might provide such information to us as necessary to fulfill and execute your requested transaction, including real estate brokers and agents, mortgage lenders, or other financial agents such as property and casualty insurance companies, for example.
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> • sharing for affiliates' everyday business purposes—information about your creditworthiness • affiliates from using your information to market to you • sharing for non-affiliates to market to you State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> • <i>RANDALL, SEGREST, WEEKS, REEVES & SONES, PLLC does not have any affiliates.</i>
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> • <i>RANDALL, SEGREST, WEEKS, REEVES & SONES, PLLC does not share with non-affiliates so they can market to you</i>

We may share your personal information with our affiliates or non-affiliates with your consent or as permitted by law. For example, if you request a transaction with a non-affiliate, such as a third-party insurance company, we will disclose your personal information to that non-affiliate as the circumstances of your transaction may reasonably necessitate. We cannot and do not control the third party's subsequent use of your information, and suggest that you refer to their privacy notices.
